# **POMPANO BEACH PIRANHAS WINTER SIZZLER**

- Sanctioned by:** Held under the sanction of USA Swimming and Florida Gold Coast Swimming, Inc.: Sanction No. SIZ030212POMP-B-10
- Sponsored by:** Pompano Beach Piranhas & the City of Pompano Beach
- Rules:** 2012 USA Swimming and FGC rules will govern this meet. Safety rules as outlined by USA Swimming and as recommended by the referee, will be in effect. Session I is timed finals for all swimmers.
- Camera Free:** The Florida Gold Coast Swimming **CAMERA FREE ZONE** policy is in effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.
- Eligibility:** Open to all current 2012 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3 The Meet Host will not be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.
- Disability Athletes:** All swimmers are welcome at this meet. Any athlete with a disability will be accommodated. Please contact the pool office ahead of time to allow for preparations – (954) 372-5029 or email [Meet@pompanopiranhas.com](mailto:Meet@pompanopiranhas.com)
- Pool/Timing:** 25 yard x 50 meters heated outdoor pool, 10 **short-course** racing lanes with separate warm-up and swim-down lanes available. Colorado Timing System® will be used. Fly-over starts will possibly be used. The competition course is not certified in accordance with 104.2.2 (C).

Water depth at the start is 5'0" in accordance with 202.3.7 (C).

**Date & Time:** **Friday, March 2, 2012**

**Session I** - Timed Finals - Warm-up at 4:30 pm. Meet starts at 5:30pm.

**Location:** Pompano Beach Aquatic Center, 820 NE 18<sup>th</sup> Ave., Pompano Beach, FL 33061.

**Directions:** From the North or South: Take I-95 or the Turnpike towards Pompano Beach and take Atlantic Blvd and go East to NE 18th Avenue. Turn Left onto NE 18th Avenue and continue to end of street to NE 8th Street. Turn Right onto to NE 8th Street and follow the road to the aquatic center. The pool is on the left-hand side.

**Entry:** All entries must be received by **February 24, 2012**.

**Seeding:** Standard Time Final Event Seed

**Refunds:** Once a team or individual entry has been received and processed, there will be no refunds in full or in part.

**Entry Limit:** 4 individual events and one Relay.

**Awards:** Individual Events: Ribbons places 1st-8th  
Relay Events: Ribbons places 1st-3th

**Deck Entries:** THE FGC DECK SEED POLICY WILL BE IN EFFECT. Deck entries permitted into open lanes only on a first-come-first-serve basis. All deck entered swimmers must present current USA Swimming Card in order to be entered.\*\*\* **Entry Fees will be Doubled if not entered electronically.**
