- Location:** North County Aquatic Complex- 861 Toney Penna Drive, Jupiter-Florida
- Directions:** Take I-95 to Exit 87A East (Jupiter/Indiantown Road) or Florida Turnpike to Exit 116 (Jupiter). Go east approximately two miles to Pennock Lane. Turn right/south on Pennock to Toney Penna (½ mile). Turn left on Toney Penna and left again into the pool parking lot. **See map on page 4 or at www.jdswim.com**
- Date & Time:** **September 9, 2017 Session** timed finals for all swimmers
Warm-up at 8:00 am. Meet starts at 9:00 am.
**Meet director reserves the right to change meet warm-up, start times, or drop some events in order to hold an efficient meet within USA Swimming/FGC guidelines and with Age Group Chair approval.*
- Pool/Timing:** 50 Meters x 25 yards heated outdoor pool, **8/10 short-course** racing lanes with separate warm-up and swim-down lanes available. Daktronics Timing System® will be used. Fly-over starts will possibly be used. The competition course has been certified in accordance with 104.2.2 (C). Water depth at the start varies from 4'4" to 8'0" depending on lane assignment accordance with 202.3.7 (C).
- Condition of Sanction** The competition course has been certified in accordance with 104.2.2(4). The copy of such certification is on file with USA Swimming. Any swimmer entered in the meet, unaccompanied by a USA-S member coach, must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Camera Free:** The Florida Gold Coast Swimming **CAMERA FREE ZONE** policy is in effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.
- Image Authorization:** All participants agree to be filmed and photographed by the official photographer(s) and network(s) of USA Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use

names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to promote such competitions.

- Rules:** 2017 USA Swimming and FGC rules will govern this meet. In granting this approval, it is understood and agreed that USA Swimming, Florida Gold Swimming and Jupiter Dragons Swim Team and Jupiter Dragons Parent Organization shall be free and held harmless from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event. Safety rules as outlined by USA Swimming and as recommended by the referee will be in effect. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches officials and/or spectators are present.
- Eligibility:** Open to all current 2017 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming. The Meet Host **WILL NOT** be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

- Entry:** All entries must be received by **Monday September 4, 2017** PLEASE enter electronically, NO MAILED entries. For electronic entries (CL or SDIF format only!!)E-mail to **coachkiril@yahoo.com**. Confirmation for electronic entries will be sent via e-mail.**Submission of electronic entries signifies that all swimmers are USA registered. Questions, please contact office at 561-339-9959
NOTE: Swimmers without registration numbers or birth dates will not be entered. * Entry Fees will be Double if not entered electronically.**
- Entry Limit:** Swimmers are limited to **5 individual events.**
- Entry Fees:** \$ 3.50 per individual event.
\$ 3.00 per swimmer ***Entry fees are made payable to JDPO (Jupiter Dragons Parent Organization). (note: one check per team)**
- Refunds:** Once a team or individual entry has been received and processed, there will be no refunds in full or in part.
- Awards:** Medals 1st – 3rd Place Ribbons 4th - 8th Place
- Deck Entries:** THE FGC DECK SEED POLICY WILL BE IN EFFECT. Deck entries permitted into open lanes only on a first-come-first-serve basis. Deadline for deck entries is 30 min. before start of meet. Policy can be seen at www.fgcswwim.org. All deck entered swimmers must present current USA Swimming Card in order to be entered.

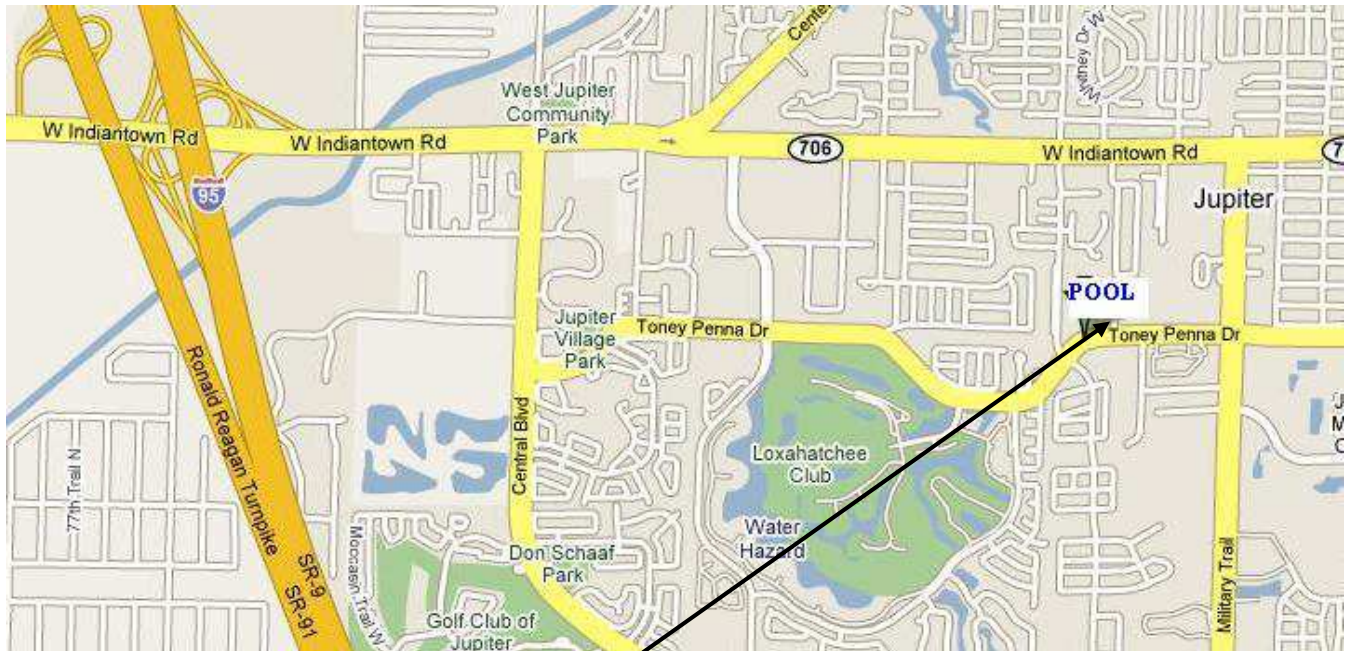

Take I-95 to Exit 87-A East (Jupiter/Indiantown Road) or Florida Turnpike to Exit 116 (Jupiter). Go east approximately two miles to Pennock Lane. Turn right/south on Pennock to Toney Penna (½ mile). Turn left on Toney Penna and left again into the pool parking lot.
