Pool/Timing: 50 Meter by 25 Yard heated outdoor pool, **7 long-course** racing lanes with

separate warm-up and swim-down lane available. Daktronics Timing System will

be used. Fly-over starts will possibly be used.

Condition of Sanction

The competition course has been certified in accordance with 104.2.2(4). The copy of such certification is on file with USA Swimming. Any swimmer entered in the meet, unaccompanied by a USA-S member coach, must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Camera Free: The Florida Gold Coast Swimming CAMERA FREE ZONE policy is in effect at

this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other

governmental authorities and/or may be barred from the facility during the sanctioned event.

Image Authorization: All participants agree to be filmed and photographed by the official

photographer(s) and network(s) of USA Swimming under the conditions

authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to promote such

competitions.

Rules: 2017 USA Swimming and FGC rules will govern this meet. In granting this

approval, it is understood and agreed that USA Swimming, Florida Gold Swimming and Jupiter Dragons Swim Team and Jupiter Dragons Parent

Organization shall be free and held harmless from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event. Safety rules as outlined by USA Swimming and as recommended by the referee will be in effect. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not

appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any

time athletes, coaches officials and/or spectators are present.

Eligibility: Open to all current 2017 USA swimming registered athletes and foreign athletes

with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from

within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure

compliance with this requirement - USA Swimming Rule 202.3.3 The Meet Host **WILL NOT** be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

Disability Athletes: All swimmers are welcome at this meet. Any athlete with a disability will be

accommodated. The coach or athlete is responsible for notifying the referee of any accommodations that are required in accordance with the USA-S rule 105.4 Please contact the pool office ahead of time to allow for preparations - 561-745-

Deck Entries: THE FGC DECK SEED POLICY WILL BE IN EFFECT. Deck entries permitted

into open lanes only on a first-come-first-serve basis. Deadline for deck entries is 30 min. before start of meet. Policy can be seen at www.fgcswim.org. All deck entered swimmers must present current USA Swimming Card in order to be

entered.

Seeding: Eligible entries shall be seeded in the following order - Long Course Meters followed

by Short Course Yards

Distance Events: 400 Free, 400 IM and 800 Free, for all ages will be swum alternating women than

men, fastest to slowest. All distance events are positive check in.

For 800 Free, swimmers must provide their own timer and counters as needed.

Awards: Individual Events: Medals places: 1st – 3rd Ribbons places 4th – 8th

Scoring: This competition is not scored.

Admission: Admission - \$3.00 per session. Heat Sheets - \$3.00 per session.

Concessions: Concession stand will be open for all sessions.


