Deck Changing: Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated

areas is not appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Exceptions may be granted with prior written approval by the vice

President of Program Operations.

Camera Free: The Florida Gold Coast Swimming CAMERA FREE ZONE policy is in

effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned

event.

Image Authorization: All participants agree to be filmed and photographed by the official

photographer(s) and networks(s) of USA Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to

promote such competitions.

Eligibility:

Open to all current 2018 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a membercoach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3 The Meet Host (WILL NOT) be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

Pool/Timing:

50 meters x 25 yard heated outdoor pool, Daktronics timing system with Omega Touchpads will be used. 8 x 50 meter racing lanes will be used with one lane and diving well open for swim down. Fly-over starts will possibly be used.

The competition course has been certified in accordance with 104.2.2 (C). Water depth at the start is a minimum of 4'6" in accordance with 202.3.7 (C).
