Deck Changing: Changing into or out of swimsuits other than in locker rooms or other designated

areas is not appropriate and prohibited

Closed Deck: Spectators will only be permitted in designated areas of the pool deck unless they

are registered with USA Swimming as an athlete or as a non-athlete working the meet. The only exception is for timers and volunteers assisting with the conduct of the meet. Coaches will be permitted inside of the roped of areas of the pool deck provided they have shown proper credentials to the meet host and do not interfere with those conducting the event. Coaches are requested to wear their

coaching credentials at all times.

Camera Free: The Florida Gold Coast Swimming CAMERA FREE ZONE policy is in

effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned

event.

Eligibility: Open to all current 2019 USA swimming registered athletes and foreign athletes

with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3 The Meet Host <u>WILL NOT</u> be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition. Non-registered or nonexistent teams must submit entries by email with information about athletes (Name, Date of Birth, USA-S ID#, events, event numbers and entry

times). The entries are considered deck entries and will be charged according to FGC deck entry policy.

Disability Athletes: All swimmers are welcome at this meet. Any athlete with a disability will

Pool/Timing: 20 lane 25 yard/meters x 50 yards/meters heated and cooled outdoor pool,

Pending the size of the meet host may run either: 1 - 10 lane short course racing lanes with separate warm up area OR 2 separate 8 **short-course** racing lanes with separate warm-up and swim-down lanes available. Colorado Timing System® will be used. Fly-over starts will possibly be

used.

The competition course has been certified in accordance with 104.2.2 (C). Water depth at the start varies from 5'6" to 13'0" depending on lane
