Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement 202.4.9(D).

Session I: Saturday - Warm-up 9:00 am. Meet starts at 10:00 am
Session II: Sunday - Warm-up 9:00 am. Meet starts at 10:00 am

***Meet director reserves the right to change meet warm-up, start times or drop some events in order to hold an efficient meet within the USA Swimming/FGC guidelines and with Meet Committee approval.**

Pool/Timing: 25 yard x 25 meters heated outdoor pool, 8 short-course racing lanes with separate warm-up and warm-down lanes available. Colorado Timing System will be used. Fly-over starts will possibly be used. The competition course has been certified in accordance with 104.2.2 (4). Water depth gradually varies from Lane 1 to Lane 8 from 5'0 to 6'0.

Rules: **2019 USA Swimming Rules** and Florida Gold Coast rules will govern this meet. In granting this approval it is understood and agreed that USA Swimming, Florida Gold Coast, and Eagle Aquatics shall be free and held harmless from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event.

Safety rules as outlined by USA Swimming and as recommended by the referee, will be in effect.

MAAPP: All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this meet.

Changing into or out of swimsuits other than in locker rooms, bathrooms, or other designated areas is not appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present (unless it has been approved prior to the event).

Closed deck: This is an optional section and can be determined by meet host. Spectators will only be permitted in designated areas of the pool deck unless they are registered with USA Swimming as an athlete or as a non-athlete working the meet. The only exception is for timers and volunteers assisting with the conduct of the meet. Coaches will be permitted inside of the roped areas of the pool deck provided they have shown proper credentials to the meet host and do not interfere with those conducting the event. Coaches are requested to wear their coaching credentials or wrist bands at all times.

Camera Free Zone: The Florida Gold Coast Swimming **CAMERA FREE ZONE** policy is in effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.

Image Authorization: All participants agree to be filmed and photographed by the official photographer(s) and networks(s) of USA Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to promote such competitions.

Conflict of Interest: Unauthorized sale, advertisement and promotion of products and/or services at the location of the competition as well as its vicinities are not allowed without the written request and written approval of the meet host and meet director. All requests must be submitted to the meet director no later than 10 days prior to the first day of the competition. Failing to comply with such order will result in removal from the facility and/or immediate vicinity.

Eligibility: **No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.** The meet is open to all current 2019 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a

racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3.

The Meet Host **WILL NOT** be accepting New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

Entry Deadline: All entries must be received by November 8, 2019.

Entry Limit: No more than four (4) individual events per day. Meet will be capped at 300 athletes on a first come first serve basis.

Entry Procedure: Electronic entries only (CL or SDIF format).

Confirmation for electronic entries will be sent via e-mail.
**Submission of entries certifies that all swimmers are current USA Swimming registered.
NOTE: Swimmers without registration number or birth dates will not be entered.

Entry Fees: \$4.00 per individual event

Refunds: Once a team or individual entry has been received and processed, there will be no refunds unless FGC Rule 1.17a.i.v applies.

Deck Entries: Deck entries permitted into open lanes only on a first-come-first-serve basis. Deadline for deck entries is 30 minutes before start of meet. All deck entered swimmers must present proof of current USA Swimming Card membership. Fees for deck entries double: \$8.00 per individual event and \$12.00 athlete facility surcharge if not already in the meet.
ALL LATE ENTRIES ARE CASH ONLY!!!

Seeding: Short Course Yards times will be used for seeding. All events will be seeded slowest to fastest with the exception of the 400 IM and 1650 free - they will be seeded fastest to slowest.

Distance events: The 400 IM and 1650 free are positive check in events. Swimmers must provide their own counters if needed.

Awards: Individual Events: Medals 1st-3rd; Ribbons 4th-8th for the following age groups: 8 & under, 9-10, 11-12, 13-14, 15 & over age groups.

Events 200 and longer will be awarded as 12 & under and 13 & over age groups.
Relays: Ribbons 1st-3rd for 12 & under and 13 & over age groups.

- Scoring:** This competition is not scored.
- Admission:** \$5.00 per session. Heat sheets will be available online for free by Thursday at www.eagleaquaticsfl.com or on meet mobile.
- Concessions:** Concession stand will be available for all sessions.
- Hospitality:** Hospitality for coaches, officials and volunteers will be available.
- Meet information:** All ages will be swum together but awarded separate by age groups.

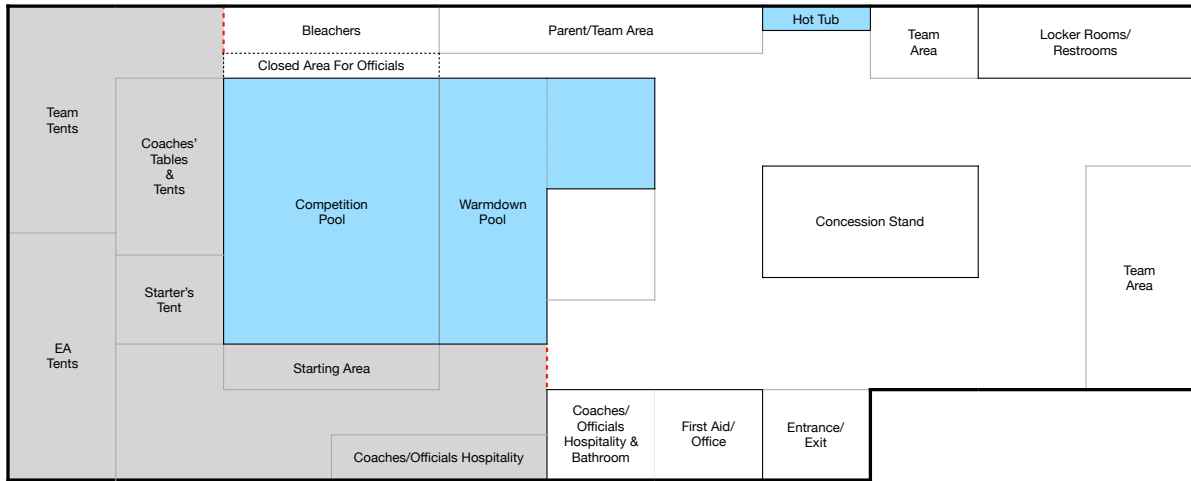
