Condition of Sanction:

The competition course has been certified in accordance with 104.2.2 (C). The copy of such certification is on file with USA Swimming. Any swimmer entered in the meet, unaccompanied by a USA-S member coach, must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Rules: **2019 USA Swimming Rules** and Florida Gold Coast rules will govern this meet. In granting this approval it is understood and agreed that USA Swimming, Florida Gold Coast, and North Miami Swim Team shall be free and held harmless from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event.
Safety rules as outlined by USA Swimming and as recommended by the referee, will be in effect.

(Deck Changing) Except where venue facilities require otherwise, Changing, in part or whole, into or out of a swimsuit (excluding a drag suit) in an area other than a permanent or temporary locker room, bathroom, changing room or other space designated for changing purposes while at a practice, competition or other pool-related activity is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

FGC Conflict of Interest Unauthorized sale, advertisement and promotion of products and/or services at the location of the competition as well as its vicinity are not allowed without the written request and written approval of the meet host and director. All requests must be submitted to the meet director no later than 10 days prior to the first day of the competition. Failing to comply with such order will result in removal from the facility and/or immediate vicinity.

Coaches/Deck Pass: Coaches must display current USS ID and/or possess Deck Pass at all times with all coaching certifications current.

Camera Free: The Florida Gold Coast Swimming **CAMERA FREE ZONE** policy is in effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.

Image Authorization: All participants agree to be filmed and photographed by the official photographer(s) and networks(s) of USA Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to promote such competition.

Eligibility: **No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.** The meet is open to all current 2019 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being **proficient in performing a racing start** or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3

The Meet Host **WILL NOT** except New or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

Disability Athletes: Swimmers with a disability are welcome at this meet. The coach or entry chairperson must alert the meet director, as to the need for any special accommodations or seeding arrangements at the time the entry is submitted. Pool/Timing: 25 yard heated outdoor pool, 9 short-course racing lanes with separate warmup and swim down lanes available. Colorado Timing System will be used. Fly-over starts will possibly be used. Water depth at the start varies from 6'0" to 6'0" depending on lane assignment accordance with 202.3.7 (C).

Date & Time: **Session I Friday - May 31, & Saturday - June 1, 2019**
Session I – Timed Finals - Warm-up 4:30 pm. Meet starts at 5:30 pm
Session II – Timed Final – Warm-up 8:00 am. Meet starts at 9:00 am

NOTE* Positive check in for 500 Free before 5:15 pm. 500 Free event will be limited to the top fastest 18 girls/boys. NT entries will for 500 Free will not be accepted. 500 swimmers are responsible for their own timer and lap counter.

****Meet director reserves the right to change meet warm-up, start times, or drop some events in order to hold an efficient meet within USA Swimming/FGC guidelines and with Age Group Chair approval.***

- NOTE:** Electronic entries can only be accepted from USA-S Registered Clubs.
Others must be submitted in 'Non Electronic form'
- Non-registered or nonexistent teams must submit entries for swim meets by email with the information about the athletes (date of birth, name, USA-S ID#, events and entry times). **The entries are considered deck entries since they have to be entered manually and they will be charged accordingly**, which currently is double the stated amount in the meet announcement. There will be a \$30 processing fee for more five or more non electronic entries.
- NOTE: Swimmers without registration numbers or birth dates will not be entered. *** Entry Fees will be Double if not entered electronically.**
- Seeding:** Yards Times will be used for seeding.
- Entry Fees:** For all events except 25's \$ 4.00 per individual event

- Facility Surcharge:** \$ 8.00 per swimmer (Heat Sheets will be Free on Line)

- Refunds:** Once a team or individual entry has been received and processed, there will be no refunds unless FGC rule 1.17 a.i.v applies.
- Entry Limit:** **Five individual events and two relays, seven total events. Relays limited to A and B teams only. 500 Free limited to top 18 fastest girls/boys.**

25's will be awarded 6 & under and 7 & 8

Open 200's will be awarded as open only

Deck Entries: THE FGC DECK SEED POLICY WILL BE IN EFFECT. Deck entries permitted into open lanes only on a first-come-first-serve basis. Deadline for deck entries is 30 min. before start of meet. Policy can be seen at www.fgcswim.org. All deck entered swimmers must present current USA Swimming Card in order to be entered.
